### Type Ahead (Auto Suggestions) for Case Law

Did you know WestlawNext Canada can auto suggest cases and legislation to make research even faster? To find cases by name, start typing a case name into the search box on the WestlawNext Canada home page. A list of suggested cases will automatically appear. The more characters you type, the more refined the list becomes. Click on the case name to go directly to the full text of that case. Suggested relevant legislation is also listed:
