WestlawNext Canada Integration with ProView

WestlawNext Canada and ProView eLooseleafs have been integrated to enable users to note-up cases even more efficiently.

When noting up a case, the Citing References tab in WestlawNext Canada now displays ProView eLooseleaf commentary that refers to and analyzes that case. This integration enriches legal research by providing users with additional secondary source information, relevant to a specific case.

ProView eLooseleaf titles are included in the Secondary Sources citing references group and the label “[ProView]” is displayed at the end of the title.
